## FREQUENTLY ASKED QUESTIONS

### ***Will we meet with a lawyer or a para-legal or secretary?***

You will meet with a lawyer.

### ***How many times will we have to come into your office?***

One of our lawyers will meet with you on two separate occasions, once to obtain the required information and instructions from you and once to review, adjust, and sign your wills and powers of attorney.

### ***Can I provide instructions by telephone?***

While it is our preference to see you in person to take instructions, we can take the initial instructions by telephone. However, you must attend at our offices to sign the final documents.

### ***How long will this process take from start to finish?***

In most cases, seven to fourteen days from the date of the first meeting with a lawyer.

### ***What sorts of things would result in us needing more sophisticated wills and powers of attorney?***

Unusual social or financial circumstances may result in the need for documentation that is out of the ordinary. For example, if one of your principal beneficiaries is incapable of managing his or her affairs, you may require a special trust for that person. If your estate is unusually large, this may open the door to the use of trusts or dual wills in order to save probate or income taxes.

### ***What happens if I need more sophisticated wills and powers of attorney?***

The lawyer who meets with you will discuss your needs and advise you on the additional costs that would be involved. In the end, it will be up to you to decide on whether you want to proceed with more sophisticated documents.

### ***Should I bring existing Wills and Powers of Attorney with me?***

Yes, if you can readily locate them.

### ***What do I need to do to prepare for the first interview?***

You need not do any extensive preparation for the first interview. You will have most of the required information in your head. Any missing information or documentation can be provided after the interview.
